The Montgomery AIA brought ten submissions to Nashville, Tennessee for the jury. Our session was conducted at the office of Tuck-Hinton Architects. The following notes were extracted from the jury's deliberation.

The ten entries provided a good mixture of project types that was nice to see as a jury. The entries were judged to be good in quality with a larger percentage of winners than the judges have typically seen from past judging. Recommend future entry participants to provide more conceptual drawings to visual describe their design concept and rely less on words. Also don't limit yourself on the number of photographs. The jury felt some of the entries could have benefited from additional photos, however make sure each photograph used does provide some additional information about the building.
