Registration Bill Update

The revised Registration Bill was agreed upon in principal at a Council Legislative Committee meeting on October 23 and at the Architect's Registration Board meeting on October 29th. The final language of this revised bill will be reviewed, and possibly approved by the Alabama Council at their meeting November 13th. We will post the bill that comes out of the Council meeting on the Montgomery Chapter's website. Please call special attention to Section 32-2-37 which now (unless changed by Council) contains language based on the NCARB Modal Law, which requires practicing architecture in the state to have a minimum 2/3 ownership by architects or engineers and a minimum 1/3 ownership by architects. As now written it also allows an existing non-conforming firm two years to comply. The next step will be to take the revised bill to allied industry representatives (engineers, contractors, etc.) seeking their support or an agreement not to object. Thanks to **Bill Wible** for keeping us informed on the bill's status.
